THE FOUNDATIONS SCHOOL - THE ORGANIZATION'S INNOVATIVE RESPONSE TO THE THIRD-GRADE LITERACY CRISIS. HISTORICALLY, ALMOST 50% OF THIRD GRADE STUDENTS IN PALM BEACH COUNTY AND ACCROSS THE STATE OF FLORIDA ARE NOT ABLE TO READ PROFICIENTLY, ONE OF THE MOST IMPORTANT ACADEMIC MILESTONES FOR STUDENT SUCCESS.
