THE FOUNDATIONS SCHOOL - THE ORGANIZATION'S INNOVATIVE RESPONSE TO THE THIRD-GRADE LITERACY CRISIS. HISTORICALLY, ALMOST 50% OF THIRD GRADE STUDENTS IN PALM BEACH COUNTY AND ACCROSS THE STATE OF FLORIDA ARE NOT ABLE TO READ PROFICIENTLY, ONE OF THE MOST IMPORTANT ACADEMIC MILESTONES FOR STUDENT SUCCESS. OPENED IN JANUARY 2021, THE FOUNDATIONS SCHOOL IS FOCUSED ON ENSURING THAT ALL STUDENTS, REGARDLESS OF SOCIO-ECONOMIC CIRCUMSTANCES, HAVE THE OPPORTUNITY TO RECEIVE A QUALITY EDUCATION.
